MEMBER IDENTIFICATION HOLDER AGREEMENT

This Member Identification Holder Agreement (hereinafter referred to as the "Agreement") is entered into between the undersigned member (hereinafter referred to as the "Member") and the New York State Law Enforcement & Community Council (hereinafter referred to as "NYSLECC"). NYSLECC shields must be renewed annually along with membership.

- Membership ID & Identification Ownership: The Member acknowledges that the NYSLECC-issued
 personal identification ID and identification (hereinafter referred to as the "Identification") is the property of
 NYSLECC and shall always remain so. The Member understands that the Identification is being issued
 solely for the purpose of membership identification. Members cannot sell, rent, or otherwise transfer any
 property of NYSLECC.
- 2. **Ownership and Legal Action**: The Member acknowledges that the Identification remains the property of NYSLECC. If the Member fails to return the Identification upon revocation, suspension, termination of membership, volunteer service, or upon demand of the organization, NYSLECC reserves the right to pursue legal action against the Member to recover the Identification and seek any associated damages.
- 3. **Receipt of Returned Identification**: The Member acknowledges that upon returning the Identification, a receipt will be issued by an authorized NYSLECC representative, confirming the return of the Identification.
- 4. **Special Privileges and Responsibilities:** The Member understands and agrees that the Identification does not grant any special privileges under the law and does not identify the Member as a police officer. The Member accepts full responsibility for any violations of rules and regulations associated with the possession and use of the Identification. Law enforcement officers have the right to confiscate the Member ID and Identification if these rules are violated.
- 5. **Lost or Stolen Identification**: In the event that the Identification is lost or stolen, the Member agrees to immediately report such loss or theft to the NYSLECC Badging Office and their immediate supervisor.
